## Western Economic Diversification Canada: COVID-19 and the Western Canadian Economy

The COVID-19 pandemic has created economic challenges around the world. Western Economic Diversification Canada is working as a trusted partner with local businesses to mitigate those challenges. - You may be eligible to receive additional funding and/or flexible arrangements.
- Further support will be determined on a case-by-case basis as the situation evolves.

- Access to federal funding to help you stay in business.
- Advice and pathfinding services to other federal programs and services available.
